Eligibility to be elected into the Board of Directors

The eligibility criteria shall be in compliance with the Sacco by-laws, the process shall have the following requirements;

- a) Must have at least **Ksh.500,000** worth of deposits and able to contribute monthly.
- b) Share capital of Ksh. 20,000.
- c) Must have been consistently servicing his/her loan(s) as per the Credit and Risk Management Committee approval. The loan(s) must be within the loaning policy provisions.
- d) Must be of good character and unquestionable integrity.
- e) Must be having an active account with Farmers Choice Sacco for a preceding minimum period of five years (5 years).
- f) Must not been mentioned in any inquiry by commission for the last ten years(10 yrs).
- g) Must pass the integrity test under chapter six (6) of the Constitution of Kenya as mentioned above.
- h) Must be over 25 years of age.
- i) Must have attained a minimum of a certificate course.
- j) Successful applicants will be subjected to vetting process.
- k) Must not have a criminal offence for the last 3 months.

Note: For supervisory committee one must have accounting knowledge.
